RELEASE, DISCHARGE, INDEMNIFY, DEFEND, HOLD HARMLESS, and PROMISE NOT TO SUE: This STABLE, doing business under its own name or any other name and its principals, officers, employees, contractors, agents and volunteers; Black Butte Stables LLC; the United States Forest Service; the United States Bureau of Land Management, the Oregon State Department of Parks and Recreation; U.S. Timberlands Services Company, L.L.C.; Cody Koch and Kristy Prosser; collectively the "releases" for any loss, liability, damage, or cost whatsoever arising out of or related to any loss, damage, or injury (including death) to the RIDER'S person or property.
9. Release the RELEASEES from any claim that such RELEASEES are or may be negligent in connection with any injury the RIDER may suffer, the RELEASEES judgment about the RIDER'S experience and ability, including but not limited to the training, maintenance and selection of horses; selection maintenance, and use of saddles, bridles, equipment and vehicles; care, fit or adjustment of saddles and bridles; condition of the facilities and land; design and maintenance of land, trails, arenas, corrals, or other facilities; instruction, leading, and supervising of RIDERS or the lack thereof.

HORSEBACK RIDING HELMET: I understand that a helmet is an essential safety item provided free of charge and that I can possible lessen or prevent injury to myself by wearing a helmet. The RIDER also understands that neither this STABLE, its employees, nor any RELEASEE can guarantee the suitability of any helmet provided.

NO HORSEBACK RIDING HELMET: The RIDER has been fully warned and advised by this STABLE that they should wear a helmet, while riding or near HORSES to reduce the severity of some of the RIDER'S potential head injuries and possibly prevent their death from happening from a fall or other occurrence. Bicycle and other type of helmets are not designed to protect the RIDER from head injury in the event of a fall from a HORSE or other HORSE related activity at this STABLE.
